You will receive your Notary Commission in the mail in approximately three (3) weeks. Your term will expire four (4) years from the date of commission. A renewal form will be mailed to you at the address listed, so please contact this office if you change your address.

NOTE: In the State of Rhode Island, Justices of the Peace **MAY NOT** perform marriage ceremonies.
